OFFICE ORDINANCE

Prime Minister's Office Ordinance No. 37 July 1, 1948

In accordance with the provisions of Article 9, Paragraph 6 of the Road Traffic Control Law, the Fee Regulations concerning Motor Vehicle Driving License shall be determined as follows:

Prime Minister

Fee Regulations concerning Motor Vehicle Driving License

- Article 1. Any person who wants to apply to the Public Safety Commission of *To*, *Do*, *Fu*, *Ken*, for the motor vehicle driver examination shall pay the fee as provided by Annexed Table No. 1.
 - Article 2. Any person who wants to apply to the Public Safety Commission of *To*, *Do*, *Fu*, *Ken*, for the delivery or re-delivery of a motor vehicle driving license certificate shall pay the fee as provided by Annexed Table No. 2.
 - Article 3. The fees provided for in the preceding two Articles can be paid in the revenue stamps.
 - Article 4. In case where the Metropolitan authorities or the authorities of a city, town or village collect fees pertaining to the motor vehicle driver examinations or the delivery or re-delivery of motor vehicle driving license certificates, conducted by the Special Warn Public Safety Commission or a municipal public safety commission of a city, town or village, the amounts of such fees shall be determined by law in accordance with the classifications as set forth in Annexed Tables No. 1 and No. 2 and within the limits of the respective amounts specified in those Tables.

Supplementary Provision:

The present Ordinance shall come into force as from the day of its promulgation.

MINISTERIAL ORDINANCE

Ministry of Agriculture and Forestry Ordinance No. 53

July 1, 1948

A part of the Staple Food Inspection Ordinance Enforcement Regulations shall be amended as follows: Minister of Agriculture and Forestry

NAGAE Kazuo

In Art. 12, Item 2, "Broken wheat, polished wheat, and crushed wheat: 1st and 2nd grades," shall read.

"Pressed barley, pressed naked barley, and pressed wheat: 1st, 2nd and 3rd grades.

Whole barley- whole naked barley, whole wheat, broken wheat, and crushed wheat: 1st and 2nd grades."

In Item 5 of the same Article, "Starch and wheat flour: 1st and 2nd grades." shall read "Starch: 1st and 2nd grades. Wheat flour: 1st, 2nd and 3rd grades." Supplementary Provision:

The present Ministerial Ordinance shall come into force as from the day of its promulgation.

Ministry of Agriculture and Forestry Ordinance No. 54

July 1, 1943

In accordance with the Designated Ration Commodities Distribution Procedure Regulation (Cabinet Instruction No. 3 of 1947), the following amendments shall be made to the Fresh Fish and Shellfish Distribution Regulations (Agriculture and Forestry Ministry Ordinance No. 28 of 1947) pursuant to the Temporary Demand and Supply Adjustment Law (Law No. 32 of 1946) as follows:

Minister of Agriculture and Forestry NAGAE Kazuo

The expression "Fresh Fish and Shellfish Distribution Regulation" shall read "Fresh Marine Products Distribution Regulation," and the expression "fresh fish and shellfish" shall read "fresh marine products."

In Article 2, Item 1 shall read as follows, and the provisions of Items 3 to 5 of the same Article shall be deleted :

1. Fresh fish of marine origin as designated by the Minister of Agriculture and Forestry.

Following paragraph shall be added to Article 2: With respect to the application of this Regulation,

the following shall be deemed to be fresh marine products:

- 1. Fresh marine products which have undergone light-salting or light-drying.
- 2. Fresh marine products which have undergone steaming or boiling.
- 3. Fresh marine products which have undergone refrigeration.
- 4 Fresh marine products which have undergone processing and are designated by the Minister of Agriculture and Forestry as fresh marine products substitutes.

In Article 4, the expression "such persons who carry fresh fish and shellfish into landing places" shall read "such persons who carry fresh marine products into landing places or produce the same therein."

In Article 5, Par. 1, the expression "monthly collection plan by types of fishery" shall be inserted after the expression "Any person who obtained a licence mentioned in Par. 1 of the preceding Article (hereinafter referred to as "licensed shipping agency") shall submit"; the expression "shall submit a decade (ten day) report" shall read "shall submit or report a decade (ten day) report"; and the expression "the form, manner or period of report" shall read "the form, manner or period of presentation or report."

Following paragraph shall be added to Article 6: The prefectural governor may issue necessary instructions to licensed shipping agencies in Class B landing places in respect to destinations, shipping quantities, shipping periods, and any other necessary items related to the monthly shipment of fresh marine products based on estimated collections.

Article 7-2. When licensed shipping agencies received instructions issued by the Minister of Agriculture and Forestry or the prefectural governor in accordance with the provisions of Article 6 or the preceding Article, they shall comply therewith.

In Article 8, the expression "(including the cases of sale of processed or cooked ones)" shall be deleted; the expression "goods carried into landing places" shall read "fresh marine products carried into landing places or produced therein"; insert the words "or produced" after the word "carried" and Item 2 of the same Article shall be amended as follows:

2. When the permission of the Minister of Agriculture and Forestry or the prefectural governor was obtained for the purpose of using the same as raw materials for processing.

In Article 9, Par. 1, Item 1, the expression "not exceeding two kan (in case of marine products specified in Article 2, Par. 2, Item 4, not exceeding one kan)" shall be inserted after the word "fishermen"; the expression "not exceeding two kan (in case of marine products specified in Article 2, Par. 2, Item 4, not exceeding one kan)" shall be inserted after the word "exceeding one kan)" shall be inserted after the word "fishermen";

Following paragraph shall be added after Par. 2 of Article 12:

The number of registrants mentioned in the preceding paragraph shall be fixed evenly to all the retail shops within a specified consuming area, except when the prefectural governor deems that any ordinary local public body or any organization of consumers which has been organized in accordance with Law and which has for its main object the purchasing business, is capable of conducting the selling business properly in the said area.

Following paragraph shall be added to the same Article:

Irrespective of the provisions of Par. 1, any licensed retailer mentioned in Article 11, Par. 1 of the Processed Marine Products Distribution Regulation may distribute to consumers in the designated consuming areas any of the marine products, specified in Article 2, Par. 2, Item 4 of the Fresh Marine Products Distribution Regulation amended by this Ministerial Ordinance, which have been designated by the prefectural governor, in the foregoing case, any licensed retailer mentioned in the same paragraph of the same Article of the said Regulation shall be deemed to be a licensed retailer mentioned in Par. 1.

In Article 13, the words "three months" shall read "six months."

In Article 16, Par. 1, the expression "not exceeding two kan (in case of marine products specified in Article 2, Par. 2, Item 4, not exceeding one kan)" shall be inserted after the expression "specified by the prefectural governor concerned."

Article 21, Paragraphs 2 and 3 shall be amended as follows:

- 2 -

After the purchasing pass-books mentioned in the preceding paragraph have been issued, no licensed retail shop shall reject the offer to purchase the fresh marine products made by any registered consumer who presents his purchasing pass-book.

After the purchasing pass-books mentioned in Par. 1 have been issued, no licensed retail shop shall sell fresh marine products to and consumer other than those registered with him, and to such registered consumers only upon presentation of their purchasing pass-books, provided that the foregoing provision does not apply to cases when the prefectural governor gives contrary instructions with the approval of the Minister of Agriculture and Forestry.

Article 21-2. When a licensed retail shop deals in marine products other than fresh or processed marine products specified in the Fresh and Processed Marine Products Distribution Regulations, it shall give notice to that effect at the shop-front or any other conspicuous position and shall sell at a distinctly separate place in the shop.

In Article 22, the expression "wite the approval of the Minister of Agriculture and Forestry" shall be deleted, and following paragraph shall be added to the same Article:

When the prefectural governor issued instructions pursuant to the provisions of the preceding paragraph, he shall submit a report to that effect to the Minister of Agriculture and Forestry.

In Article 22-2, the expression "or the prefectural governor" shall be inserted after the expression "the Minister of Agriculture and Forestry"; and following two paragraphs shall be added to the same Article :

Unless the fresh marine products are designated in accordance with the provisions of the preceding paragraph (hereinafter referred to as "designated fresh marine products"), no person is permitted to be engaged in selling the same or selling on consignment of the same by purchasing or by being entrusted to sell the same on consignment, (hereinafter referred to as off-shore purchases) before the said products are carried to landing places.

When the prefectural governor has designated the kinds of fresh marine products in accordance with the provisions of Par. 1, he shall forthwith report to that effect to the Minister of Agriculture and Forestry.

In Article 22-3, Par. 1, the expression "Any person who is engaged in the business of selling those fresh marine products which fall under the category of kinds designated by the Minister of Agriculture and Forestry in accordance with the provisions of the preceding Article (hereinafter referred to as designated fresh marine products") and which are not carried into landing places or sell the same on consignment by purchasing or being entrusted to sell the same on consignment" shall read "Any person who is engaged in off-shore-purchases of the designated fresh marine products," and the expression "or the prefectural governor" shall be inserted after the expression "the Minister of Agriculture and Forestry," in Paragraphs 2, 3, and 6 of the same Article, the expression "or the prefectural governor" after the expression "or the Minister of Agriculture and Forestry," in Par. 4 of the same Article, the expression "or the prefectural governor" after the expression "or the prefectural governor" after the expression "the Minister of Agriculture and Forestry," and the expression "designated fresh fish and shellfish" shall read "designated fresh marine products."

In Article 22-4 and Article 22-5, Par. 1, the expression "or the prefectural governor" shall be inserted after the expression "the Minister of Agriculture and Forestry."

Supplementary Provisions:

This Ministerial Ordinance shall come into force as from the day of its promulgation. However, with respect to the marine products specified in Art. 2, Par. 2, Items 3 and 4, this Ordinance shall come into force as from the day after one month from the day after one month from the day of its promulgation.

Any person who is a licensed collecting agency or a licensed receiving agency mentioned in Article 5 or Article 13 or the Processed Marine Products Distribution Regulation on the day when this Ministerial Ordinance comes into effect, is allowed to be engaged in the business of a licensed shipping agency or a licensed receiving agency, with respect to the shipping or receiving of marine products specified in Article 2, Par. 2, Item 3 of the Fresh Marine Products Distribution Regulation amended by this Ministerial Ordinance, from the day of its enforcement till August 31, 1948, irrespective of the provisions of Article 4, Par. 1, or Article 11, Par. 1 of this Regulation.

Ministry of Agriculture and Forestry Ordinance No. 55

July 1, 1948

In accordance with the Designated Rationed Commodities Destribution Procedure Regulations (Cabinet Instruction No. 3 of 1947) and based on the provisions of Art. 1, Par. 1 of the Temporary Demand and Supply Adjustment Law (Law No. 32 of 1946), a part of the Processed Marine Products Distribution Regulations (Ministry of Agriculture and Forestry Ordinance No. 62 of 1947) shall be amended as follows:

Minister of Agriculture and Forestry

NAGAE Kazuo

"Designated marine products" shall read "processed marine products."

"Dried herring eggs" mentioned in Art. 2, Par. 1, Item 2 shall be deleted; "Salted cuttle fish and pickled cuttle fish" mentioned in Item 3 of the same paragraph shall read "and salted cuttle fish"; in the same paragraph, Item 7 shall be deleted, Item 8

shall become Item 7, and the number of its following Items shall be moved up by one in order, and Item 10 of the same paragraph shall be amended as follows; and Par. 2 of the same Article shall be deleted:

10. Other processed marine products designated

by the Minister of Agriculture and Forestry.

Art. 8-2. As to the processed marine products designated in accordance with the provision of Art. 2, Par. 1, Item 11, the Minister of Agriculture and Forestry may not apply the provisions from Art. 3 to the preceding Article thereto.

In case of the preceding paragraph the Minister of Agriculture and Forestry shall designate by public notice the names of processed marine products to be so affected.

Art. 9. A prefectural governor may, if he deems it necessary to do so in order to secure the distribution of processed marine products, designate the consuming area of processed marine products.

In Art. 10, "Minister of Agriculture and Forestry or" shall be deleted.

Art. 11, Pars. 2 to 5 shall be amended as follows:

A person who is qualified to be granted a license in accordance with the provisions of the preceding paragraph shall be one who is equipped both in materials and labor necessary for carrying out the distribution business of processed marine products and has obtained not less than such number of registrants in the designated consuming area as the prefectural governor designated by public notice.

The prefectural governor shall fix the number of registrants mentioned in the preceding paragraph evenly to all applicants as retailer within a specified district ion the said consuming area; provided, however, that this shall not apply in case where the said governor deems that an ordinary local public body or an organization of consumers which has been established in accordance with Law and which has for its main object the purchasing business is capable of conducting the selling business properly in the said area.

Any person who intends to obtain a licence mentioned in Par. 1 of the present Article shall submit to the prefectural governor an application for a licence as retailer, stating his name and other particulars prescribed by the prefectural governor, together with a document proving the number of registrants mentioned in Par. 2 of the present Article (in the case of an organization, its name and the name of its representatives shall also be stated in said application, which shall be accompanyed with its Articles of Association or other kind of documents similar thereto in nature).

The term of validity of a licence mentioned in Par. 1 of the present Article shall be not more than six months.

Par. 7 of the same Article shall be amended as follows:

A prefectural governor may issue to any licensed retailer within his jurisdiction necessary orders relating to the distribution methods of processed marine products and other matters.

In Art. 14, "any person who carries the designated marine products into the designated consuming area" shall read "any person who carries the designated marine products into the designated consuming area or produces the same therein."

Art. 18. A prefectural governor may, in accordance with rules laid down by the Minister of Agriculture and Forestry, issue purchasing pass-books for the purchase of the processed marine products (hereinafter referred to as purchasing pass-books) to consumers in the designated consuming area within his jurisdiction.

If, in cases where purchasing pass-books mentioned in the preceding paragraph have been issued, a consumer who has registered with a licensed retailer makes an offer to purchase processed marine products by presenting his purchasing pass-book, the latter shall not refuse to sell the same.

When purchasing pass-books mentioned in Par. 1 of the present Article have been issued, no licensed retailer shall sell a processed marine product to any person other than those who have registered with said retailer and who present their purchasing passbooks, except in case where the prefectural governor designates otherwise with the approval of the Minister of Agriculture and Forestry.

In Art. 20, Par. 2, "coupons for purchase by subscription mentioned in Art. 18, Par. 1" shall read "Purchasing pass-books mentioned in Art. 18, Par. 1."

Art. 21. A licensed retailer shall, in case he sells marine products other than those to which the Processed Marine Products and Fresh Marine Products Distribution Regulations are applied, give notice to that effect at the front of his store or at any other conspicuous position and sell the same at a distinctly separate place in his store.

Supplementary Provisions:

- 4

The present Ministerial Ordinance shall come into force as from the day one month after the day of its promulgation.

Any consuming area (excluding the designated consuming areas of frozen marine products) which has been designated by a prefectural governor in accordance with the provisions of Art. 9, Par. 2 of the Processed Marine Product Distribution Regulations before the day of enforcement of the present Ministerial Ordinance and which continues to be as such on the said day shall be deemed as designated in accordance with the provisions of Art. 9 of the said Regulations amended by the present Ministerial Ordinance.

Any retailer who has been licensed by a prefectural governor before the day of enforcement of thepresent Ministerial Ordinance and continues to be as such on said day shall for the term of validity of the license be deemed as licensed under the provisions of Art. 11, Par. 1 of the Processed Marine Products Distribution Regulations as amended by the present Ministerial Ordinance.

With regard to the application of penal provisions to acts done prior to the enforcement of the present Ordinance, the old provisions shall remain applicable even after the enforcement of the said Ordinance.

INSTRUCTIONS

Economic Stabilization Board Instructions No. 38

July 1, 1948

To all Ministries In accordance with the provisions of Article 15 of the E.S.B. Ordinance, a part of the Instructions No. 1 issued 1948 shall be amended as follows:

President of the Economic Stabilization Board ASHIDA Hitoshi

 After Paragraph 1 of Article 1, the following paragraph shall be added:

"'Maintenance' mentioned in the preceding paragraph shall mean the minimum upkeep necessary to continue a facility in sound working condition. However, maintenance shall not include the improvement of any plant, facility or equipment by replacing material which is still usable with material of a better kind, quality or design."

2) In Paragraph 1 of Article 2, "..... the construction project sheets of each quarter shall be presented to" shall be added to after "..... the construction project sheets shall, in accordance with the forms decided by E.S.B., be presented to"

3) After the end of Article 2, the following Article shall be added :

"No telecommunications operating agency shall make any replacement of telecommunications equipment or facilities unless such replacement meets one or more of the following requirements:

a. Essential maintenance in order to insure protection and maintenance of existing services.

b. In case where essential additions to existing services cannot be made except by replacing the existing facilities.

Despite of the provisions in the preceding paragraphs, in case when any operating agencies need to make the improvement of existing services, they shall, in accordance with the forms decided by E.S.B., make specific applications, together with proof that the improvement cannot be made without replacing existing facilities, and with the construction project sheets mentioned in [Paragraph] 1 of the preceding Article, and get the approval of E.S.B. Supplementary Provisions:

The competent Ministries shall, in accordance with the provisions of the present Instructions, make necessary amendments in the Orders based upon the Temporary Demand and Supply Adjusting Law.

The present Instructions shall come into force as from the day of its promulgation.

1. In accordance with the provisions of Art. 2, Par. 1, Item 1 of the Fresh Marine Products Distribution Regulation (hereinafter referred to as "the Regulation"), fresh fish of marine origin shall be designated as specified in Attached Table 1.

2. In accordance with the provisions of Art. 2, Par. 1, Item 4 of the Regulation, these fish which are manufactured out of fresh marine products and which are substituted for fresh marine products shall be designated as specified in Attached Table 2.
