Dear Friends,

In 2013 Project Harmony continued to serve more than 2,800 children from the Omaha metro and southwest Iowa areas. These are children who are being evaluated for child sexual abuse, physical abuse and neglect. Project Harmony provides medical exams, forensic interviews and advocacy to children who have suffered the worst that life has to offer. In this year, the agency expanded the coordination of care and developed additional multidisciplinary teams allowing for more community professionals to give their expertise in caring for and serving young victims of abuse and neglect. Additionally, Project Harmony

multidisciplinary teams allowing for more community professionals to give their expertise in caring for and serving young victims of abuse and neglect. Additionally, Project Harmony was able to partner with a Yale University evidence-based program and deliver a new intervention to children exposed to traumatic events (Child and Family Trauma Symptom Intervention.) This program allows for children and their care provider to receive crisis counseling immediately following the investigation and has already demonstrated terrific outcomes. The training efforts, aimed at early identification and response to child abuse, delivered training to a record number of over 9,400 professionals this year. This team of staff have provided education to our community, region and across the country delivering best practice and skill building training to those who work with vulnerable children.

This beautiful co-located facility, a national model, now has 180 professionals representing Law Enforcement, Child Welfare (government agencies) and other non-profits such as representatives from Child Saving Institute, Lutheran Family Service and the team of professionals at Project Harmony. Collectively, we are so grateful for your support and care for those affected by child abuse.





Since opening its door in 1996, Project Harmony has become a beacon of hope for more than 20,000 children. Project Harmony is a national role model of public and private collaboration. This relatively small nonprofit organization has established under one roof, efficient and effective collaboration that is dramatically improving how the Omaha community responds to children at risk.

One child. One place. One time.

This philosophy is at the core of all we do at Project Harmony. Every child deserves the opportunity to grow up safe, happy and healthy; and as adults we have no greater responsibility than the protection of our children against victimization, abuse and neglect. Abuse steals their innocence, replacing it with fear and hurt that can damage young lives in a way that can take a lifetime from which to recover. Our services lead to healing for victims, including:

Forensic Interviews – Professionals, trained in child development and court approved questioning techniques, conduct video-taped forensic interviews with children when requested by law enforcement and/or Child Protective Services (CPS). One of the goals of the interview is to reduce the number of times a child must tell their story of abuse/neglect. Reducing the number of interviews reduces the trauma to the child. Video-taped interviews conducted at a child advocacy center also increases the likelihood of a successful prosecution. In 2013 the agency provided 1289 forensic interviews to suspected abuse victims.

Medical Evaluation – Child Protective Service (CPS) workers and law enforcement refer children to Project Harmony for forensic medical evaluations. Project Harmony has a pediatrician with a sub-specialty training and certification in Child Abuse and Neglect. Dr. Suzanne Haney is now in a joint partnership with Children's Hospital & Medical Center and is also an Adjunct Faculty Member at the University of Nebraska Medical Center. In addition to delivering direct services to child abuse victims, extensive coordination and training occurs with local hospitals and medical providers to ensure proper reporting and identification of child abuse. The agency also employs two nurse practitioners. In 2013 the agency provided 1084 exams to child abuse victims.

Advocacy and Support – Advocacy and support is provided to all child abuse victims and their non-offending family members. As a member of the Multidisciplinary Team, the advocate meets with all parents and ensures that they understand the process of the investigation. They serve as a resource to the family, assisting them with accessing services and following the after care plan. In 2013 Project Harmony hired an additional advocate who is Spanish speaking. Because of this Project Harmony has seen a significant increase in the number of Spanish only speaking families being served. In 2013 the agency provided support to 3,467 children and their families.

Multidisciplinary Team Coordination – Project Harmony has six employees serving as team coordinators. This effort was prioritized by the Nebraska Legislature as a result of legislation that requires that the team approach be utilized and that children are to be evaluated at a Child Advocacy Center. As a result, state funding has been allocated to support this effort. Project Harmony staff and other professionals review cases to make certain children do not "fall through the cracks." Teams work toward making changes and finding solutions to any problems in reporting and investigating child abuse, permanency, treatment and system issues. In 2013 the agency provided team coordination to 944 children and their families.

Training and Education – In 2007 Project Harmony launched a training effort to help educate community members on how to recognize and report child abuse. Training offerings include:

Child Abuse and Neglect 101, Child Abuse and Neglect 201, Home Visits 101, Medical Aspects of Child Abuse and Neglect, Field Interviewing in Child Abuse and Neglect and Darkness to Light: Stewards of Children. In 2013 the agency trained more than 9,000 people. **Triage Center** – In partnership with Child Saving Institute, children in immediate need of refuge find a welcoming center where they are greeted by professionals. Children are provided a light meal, clothing, and a medical exam if needed. They can nap, play or just relax as arrangements are made for their safety. Prior to the availability of this center, children often waited in the lobby or in the back of a police cruiser for hours. **In 2013 the Triage Center provided safety and comfort to 755 children.**

Mental Health Crisis Support – Project

Harmony launched an evidence-based crisis support treatment model called CFTSI: The Child and Family Traumatic Stress Intervention. It is a family strengthening intervention that aims to reduce the early post-traumatic stress symptoms; to decrease the likelihood of traumatized children developing long-term post-traumatic psychiatric disorders; and to identify children who need longer-term mental health care. This program was developed by Yale University and our full time therapist has been trained by the Yale program. **NEW in 2013**.

BE THE END – Child victims of abuse are counting on you to speak up for them. A child's safety is an adult's responsibility. Believe children when they tell you someone is hurting them – you may be the only person they tell.

In Nebraska, we are all mandated to act on "any reasonable cause to believe that a child or incompetent person has been subjected to...abuse/neglect" and to report to law enforcement or the Child Abuse/Neglect Hotline on behalf of that person.

In 2002 Ashley Judd found her true calling as a humanitarian and voice for those suffering in neglected parts of the world. After her first trip to southeast Asia, Ashley knew that she wanted to advocate on behalf of the vulnerable. During her travels she started to write diaries detailing stories of survival and resilience. But along the way, she realized that she was struggling with her own emotional pain, stemming from childhood abandonment and abuse. In 2006 Ashley sought in-patient treatment for the grief that nearly killed her. Judd found not only her own recovery and an enriched faith but the tools that energized and advanced her feminist social justice work. Ashley described her odyssey, from lost child to fiercely dedicated advocate, from anger and isolation to forgiveness and activism.
