Notice of Intent to Rely on UK Substituted Compliance Order

Pursuant to paragraph (a)(16) of the Order Granting Conditional Substituted Compliance in Connection with Certain Requirements Applicable to Non-U.S. Security-Based Swap Dealers and Major Security-Based Swap Participants Subject to Regulation in the United Kingdom (the "Order"), 1 Citigroup Global Markets Limited ("CGML") hereby provides notice to the Securities and Exchange Commission (the "Commission") of its intent to rely on the Order.

CGML is a "Covered Entity" as that term is defined in paragraph (g)(1) of the Order. CGML intends to rely on substituted compliance with respect to certain requirements of the Securities Exchange Act of 1934 (the "Exchange Act") for which the Commission has provided substituted compliance determinations. The chart below lists each relevant paragraph of the Order in Column A, whether CGML intends to rely on the substituted compliance determination in that paragraph in Column B, and, where relevant, the class of security-based swap ("SBS") transactions (for transaction-level requirements) or SBS business (for entity-level requirements), for which CGML intends to apply substituted compliance.
