O'burg budget fails in split vote again

OGDENSBURG — A resolution to accept a preliminary budget in Ogdensburg failed in a 3-3 vote Tues-

Voting against the measure were Deputy Mayor Steve Fisher, Councilor John Rishe and Councilor Bill Dillagbough.

Voting in favor were Mayor Jeffrey M. Skelly, Councilor Dan Skamperle and Councilor Michael Powers.

According to the charger the preliminary budget is required to be adopted by the end of the month and the final budget is to be adopted by Dec. 1.

Pushing against the passage was Rishe. He said that while he believed the budget presented by staff was decent, he believes the budget workshops should be held prior to passage.

The workshops are planned for Oct. 16, Oct. 30 and

Staff's proposal would leave the city's tax rate flat; the levy, which is the total amount raised from property tax collections, would increase by \$1.17 million - just shy of 25%.

That's largely due to a citywide revaluation of property taxes that sent home values soaring.

In order to raise property taxes by an amount that exceeds 2% plus various allowances, a public hearing must be held and a resolution must be passed or the city would risk losing state aid.

Despite recommendations from staff, Rishe says he does not believe the override should be approved until the city is closer to finalizing a budget.

It is extremely unlikely, based on current numbers, that the city would come in under the tax cap.

Cost concerns raised over state's push toward electric future

MASSENA — With state officials requiring the use of electric fleet vehicles in the coming decade, demand for electricity will continue to rise along with residential bills, according to a Massena man.

Phil Lashomb, a Massena resident, recently told town council members that he is concerned about the potential impact the transition to electric vehicles will have on residential electricity rates.

Lashomb questioned where the additional power to charge vehicles would come from, whether it would be from the New York Power Authority or Massena Electric.

"Massena Electric is only allotted a certain amount of megawatts and if we go over, you have to buy it out on the market," he

Lashomb said that in turn would drive up electric bills for

When it comes to vehicles charging, Lashomb said it's not just about the school district's buses that would use excess power but also personal vehicles.

In recent years, electric vehicles have taken a larger share of the personal vehicle market.

Coupled with a push from politicians to transition to electric vehicles in the coming years, Lashomb said that may make matters worse for individuals on a

Council's failure to pass tax cap override spells catastrophy, says candidate

 ${\tt OGDENSBURG-Mayoral\,can-}$ didate Michael Tooley says a failure to pass the tax cap override would be catastrophic for the city of Ogdens-

Tooley is the only candidate who will appear in the mayoral line in November.

On Tuesday he spoke at the public meeting calling on council to set a public hearing on the matter, which is necessary as a precursor to passing the tax cap override.

Although it has not been adopted by council, a spending plan prepared by staff would increase the tax levy by \$1.17 million nearly 25 percent, keep the tax rate flat and exceed the state's proposed tax cap by 94%.

Councilor John Rishe, as well as Deputy Mayor Steve Fisher and Councilor William Dillabough, said they will not consider adopting the tentative budget, or passing a tax cap override until after budget workshops take place.

Those are currently set for Oct. 16 and Oct. 30 and Nov. 6.

Tooley also pointed out that it appears that regardless of the results of the upcoming election it is likely that at least three members of city council will be coming in with no prior experience as a councilor.

Currently there are five candidates seeking four council seats.

Fisher, Rishse and Dillagbough's seats will be up for grabs, as well as an unexpired term for Nichole Kennedy's seat.

Four Democrats, including Jennifer Stevenson, R. Storm Cilley, Michael Weaver and Donna Trimm, are hoping to fill the vacancies.

On the Republican line, Robert Edie is hoping to secure one of the

Tooley suggested the city budget for workshops or training for those councilors. He also suggested that the city should look to the New York Conference of Mayors for support.

Tooley questioned several of the staff proposed changes in various budget lines, however at this time the council has not publicly discussed details of staff's proposed budget.

Tooley suggested that the proposed increases in sewer and water could likely be reduced as the current fund balances for both are "healthy enough."

"As was noted at the last city council meeting. We need to find ways to provide relief to the proposed increase in the water fund and the sewer fund rates when you consider the significant increase in property taxes used to balance the 2023 general fund."

Massena budget to reflect hikes in retirement, comp

MASSENA - Village of Massena officials will have to work around increases in retirement and worker's compensation contributions in next year's budget following notification from New York State.

According to Village Treasurer Kevin Felt, the New York State Retirement System recently released rates that show an increase that could range from 1.8% to 4.5%.

Those varying increases will have to be used when preparing the village's budget for next year, Felt told trustees.

More specifically, Felt says the Employee Retirement System (ERS) has estimated increases in the range of 1.8% to 2.8%, while increases for the Police and Fire Retirement System (PFRS) will range from 3.2% to 4.5%.

That won't be the only increase the village has to plan for however, as the worker's compensation bill has increased \$66,032.

The village was notified of that bill's increase, which comes from St. Lawrence County, last month.

The reason for the change stems from the formula used when computing worker's compensation, according to Mayor Greg Paquin.

"It used to be a split between assessed property and population. They moved away from that and really now it's based on your experience rate," he said.

Paquin said that calculations are now based on the types of jobs that individuals have when working for a municipality, along with salaries.

"To be honest with you, we got dinged with two rather large salaries for people that retired. Next year that should go down because they won't be on the books," he said.

The formula was updated in 2019, Paguin said. When calculating rates, Paquin also said job types play a large role, with police officer costing more in the long run.

"Obviously the job of a police officer is a lot higher risk than say a teacher," he said.



Former school super to serve 10 to life for trying to entice a minor into sex

MORRISTOWN -- Former Morristown Central School superintendent will serve 10 years to life imprisonment for attempting to entice a minor into engaging in unlawful sexual acts.

Bruce A. Wakker, 68, was convicted earlier this week following a three-day trial.

United States Attorney Carla B. Freedman and Alfred A. Watson, Acting Special Agent in Charge of the Albany Field Office of the Federal Bureau of Investigation (FBI), made the announcement, a release from the U.S. Attorney's office said.

Wakker, of Syracuse, was arrested Thursday, June 11, 2020 and charged with attempting to entice or coerce a child.

Wakker served as Morristown Central superintendent from 2000 to 2003, when the school board failed to extend his contract and Beverly Ouderkirk was appointed as interim superintendent, according to the state Education Department.

According to the United States Attorney's Office, the trial evidence established that from November 2019 to June 2020, Wakker exchanged thousands of sexually explicit text messages with people he believed to be a 9-year-old girl and her mother, respectively.

In these text messages, Wakker, among other things, discussed performing different sexual acts with the 9-year-old and sent the 9-yearold pictures of his genitalia, the attorney's office says.

Wakker arranged to meet with the presumed mother and 9-yearold in person. On June 11, 2020, he traveled from Syracuse to New York Mills, New York, for the purpose of engaging in sexual intercourse with the 9-year-old, documents say.

On several occasions, Wakker directly instructed the girl how to use various sexual objects and aids he purchased and mailed to her and her mother, federal authorities said.

Sentencing is scheduled for February 28, 2024, before United States District Judge Glenn T. Suddaby in Syracuse, at which time the defendant faces a minimum term of imprisonment of 10 years, a maximum term of life, a fine of up to \$250,000, and a term of supervised release of at least 5 years and up to life, authorities say.

He will also have to register as a sex offender.

The FBI Child Exploitation Human Trafficking Task Force investigated this case. This task force includes FBI Special Agents and Investigators of the New York State Police, Bureau of Criminal Investigation (BCI), and the Colonie Police Department. Assistant U.S. Attorneys Carling Dunham and Douglas Collyer prosecuted this

Officials say the case was prosecuted as part of Project Safe Childhood, a nationwide initiative designed to protect children from online exploitation and abuse.

The program is led by the United States Attorney's offices, Project Safe Childhood marshals federal, state, and local resources to better locate, apprehend, and prosecute individuals who exploit children via the Internet, as well as identify and rescue victims.

St. Lawrence County no longer sanctuary county

CANTON — St. Lawrence County has been delisted as a sanctuary county following action from County Attorney Steve Button and Sheriff Brooks Bigwarfe to correct a clerical error by the Center for Immigration Studies (CIS).

County officials say the error was made in 2017, seemingly designating the county as a sanctuary county that would house migrants if state officials deemed it prudent.

Legislators passed a resolution on Sept. 11 to rectify the designation, objecting to the county's inclusion on

Officials say the designation came to light after an Aug. 29 report from Director of Homeland Security Alejandro Mayorkas was released, outlining eleven sites within the state that were deemed appropriate to house migrants.

On the list was Massena International Airport, which caused consternation among residents, local, state and federal officials who objected to its inclusion.

Officials in Massena and with the county all said at the time that they were caught off guard and were given no prior notice from Department of Homeland Security officials that the site was under consideration.

Legislators and Sheriff Bigwarfe all publicly objected to the inclusion the county on the sanctuary list and "public pronouncement of enforcement of immigration measures against illegal aliens when initially discovered in 2017, the County remains listed as of today," according to the resolution passed on Sept. 11.

County officials were also critical of the non-profit CIS for listing the county as having failed to cooperate with federal Immigrations and Customs Enforcement Detainers since

In a letter sent to CIS, dated Sept. 18, 2023, Button refuted claims by CIS that the county was not compliant with CIS detainers and requested the county be removed from the list of sanctuary counties.

"It was alleged that the St. Lawrence County Sheriff had refused to comply with an ICE Detainer in August of 2014, a fact which the St. Lawrence County Sheriff denied at the time of the issuance of your original report," Button wrote.

That initial contestation of CIS's claim came from former Sheriff Kevin Wells, who retired in Dec. 2019. Sheriff Bigwarfe assumed office in Jan. 2020, having been elected in Nov. 2019.

Included with the letter was a copy of the resolution, along with a sworn affidavit from Sheriff Bigwarfe in which he stated "no such policy exists under his administration to refuse to comply with ICE Detainers and he will comply with all validly issued detainers, as he has done so during his tenure in

Button also included a copy of the 2017 US ICE notation that he said "erroneously listed our County as uncooperative with iCE Detainers."

"Please accept this letter, and accompaniments, as a formal demand to de-list St. Lawrence County, New York as a Sanctuary County and to make such other and further amendments as necessary to delist our municipality based upon the allegation that we are either incapable or unwilling to comply with federal immigration detainers," Button concluded.

As part of the initial declaration, St. Lawrence County was listed

amongst a group of sanctuary cities and counties that were compiled by Immigration and Customers Enforcement (ICE) as a result of the CIS listing, officials say.

Part of the issue at hand is the fact that the county has been listed as being non-compliant with immigration detainers issued by ICE, which allows local law enforcement officers to detain individuals who have been arrested on criminal charges and who ICE has probable cause to believe are removable non-citizens, according to officials.

According to a sworn affidavit by Sheriff Bigwarfe, the Sheriff's Office never failed to comply with ICE detainers and in fact has always sought to comply with federal authorities.

Bigwarfe stated "To the best of my knowledge, St. Lawrence County has never refused to comply with a validly issued ICE Detainer and would not do so as that would be contrary to federal law. Upon information and belief, St. Lawrence County, New York has previously requested the removal of the designation by the Center for Immigration Studies from their list of Sanctuary municipal entities."

Legislators also wrote that the county "has had a long history of honoring the requests of Immigration and Customs Enforcement to detain individuals believed to have violated United States laws and believed to be present in this Country illegally," refuting a claim by CIS that the county was non-compliant for years.

In the resolution, legislators say the county will continue to comply with ICE detainers "should migrants be sent to this County and detainers lodged for their detention and transfer to ICE custody."

provide bags and rakes for athletes to use and coaches will call before athletes are sent to homes.



Green hydrogen producer plans 90 jobs in Massena

MASSENA — The world's largest producer of green hydrogen is moving forward with a facility that is slated to be built on Pontoon Bridge Road in Massena; a move that will bring at least 90 jobs to the town.

At a public hearing held by the St. Lawrence County Industrial Development Agency in Massena Oct. 10, Air Products and Chemical Director of Government Relations Trip Oliver told officials work has already begun at the site.

"There's some equipment on site right now. Site clearing will occur over the next couple of months. There's some limitations on how much site clearing we can do at this point because we're still waiting for an Army Corps of Engineers wetland determination that we should hopefully receive in the next month or so," he said.

The facility, which will cover over 80 acres, will likely take about three years to complete before opening in

Construction will bring a number of temporary jobs to the area as well, with an estimated 500,000 hours of construction work to be done, according to Oliver.

Once at its peak, construction at the site would lead to the employment of about 350 people full-time.

Anywhere from 20 to 40 jobs will be created in the near future with site clearing needed, Oliver said.

"Next year I think we're going to ramp up to maybe 100, 125 jobs on site. And then in 2025, that's when you're going to get peak construction at about roughly 350 jobs on site," he said.

But the jobs won't stop there, with 90 jobs coming to Massena, 64 of which will "likely be at the facility" and another 26 jobs that will "be in either an office location somewhere in this area or at the site," Oliver said.

Oliver said local contractors will be hired to help with maintenance throughout the years too, with around \$2 million in maintenance costs expected every year.

Oliver said larger projects are also needed every few years, requiring further investment.

"Every few years we have to do a major turnaround. That's an additional \$5 million a year," he said.

According to Oliver, Air Products has a deal in place with the village

of Massena to purchase \$300,000 worth of water per year from the Massena Water Department.

"The process with this site will

use approximately 1 to 1.2 million gallons of water a day. Of that water, about 300,000 or so will then be returned to the St. Lawrence River, actually cleaner than it was when it came out," Oliver said.

Businessman William Fiacco asked if the process to create hydrogen in Massena is currently in use at other facilities.

Harry Johnston, a senior business manager for Air Products, said the Massena plant would be the first to use electrolysis to create the

"We are the world's largest producer of hydrogen. All that hydrogen comes today from some type of carbon source, whether it's natural gas or coal or other organic sources. We have this facility that's going in here. We have a very large facility in Texas that we're building right now. We have a very large facility in Saudi Arabia that we're building right now, and a number of other facilities in Canada and the U.S. that we're contemplating to do basically the same thing we're doing here. So, this will be one of our first," he said.

Other questions from audience members arose during the public hearing as well, with one member asking what the hydrogen would be

Oliver said the company and the fuel produced in Massena would be used for large vehicles that transports goods throughout the country.

Officials say the "vast majority of the product from this plant we see going into what we call the mobility market."

Johnson also told attendees that other businesses could possibly come to Massena, noting that some have approached Air Products in recent months but nothing definitive is in the works.

"I'm not aware of any immediate synergies that are being worked on right now but the concept is absolutely true, that if a company needed a gas or liquid hydrogen, they would save money by co-locating here," he said.

Expansion was also a topic of conversation, with Johnson confirming that the facility could be expanded in the future however it "will be determined by the market, the demand for hydrogen," Johnson

County overtime on the rise

CANTON — Overtime expenses continue to mount for multiple departments around the county, forcing legislators to make budget modifications to cover the added expenses.

Two modifications were approved during the full board meeting on

The first, which totaled \$82,163, was for the Sheriff's Office.

Officials say the Sheriff's Office will exceed the budget in the criminal overtime account for 2023.

That account is related to deputies and other officers in the criminal division.

Officials say funds that will be used to cover the overages were found after reviewing all accounts, allowing the department to cover the overtime expenses from existing funds.

In the resolution, it is also stated that the department found it necessary to transfer funds from targeted contingency for the overtime accounts.

Overtime expenses continue to mount for the County Clerk's Office

According to the resolution, a budgetary measure during the 2023 budget process identified a percentage of appropriations for departments with overtime expenses and located those funds in a contingency account.

Officials say the Clerk's Office will exceed the identified percentage of appropriations included in the 2023 budget for overtime costs, necessitating the \$22,500 budget modification.

Those funds will be transferred from the targeted contingency account to cover the overtime expenses incurred, according to the resolution.

County extends state of emergency over migrant crisis

CANTON — St. Lawrence County has once again extended the state of emergency that was first declared in May due to the ongoing migrant crisis afflicting New York City and surrounding states.

The state of emergency has been extended to Sunday, Nov. 5.

The declaration will be reviewed prior to its expiration to determine if an extension should be considered, officials say.

County officials first passed a state of emergency on May 12, 2023 "to address the concerns associated with the May 11, 2023 expiration of the Title 42 Order."

"In specific, the Title 42 Order prohibited the migration into the United States by "covered noncitizens" traveling from Canada or Mexico who would otherwise be introduced to a port of entry or U.S. Border. St. Lawrence County has over seventy-five (75) miles of border with Canada with two border crossings in Massena and Ogdensburg that anticipate an influx of individuals who may be seeking shelter," County Administrator Ruth Doyle wrote the release.

County officials say the state of emergency was extended over concerns about an anticipated "surge of migration into the United States," which could lead to migrants being placed in St. Lawrence County.

Governor Kathy Hochul issued a fourth executive order on Sept. 24 of this year to extend the state's own state of emergency, which is currently expected to remain in place until Oct. 23, 2023.

County officials say local emergency orders "may be promulgated by the Chair of the Board of Legislators in accordance with Article 2-B of the New York State Executive Law during the State of Emergency. Emergency orders would be issued in order to protect life and property and to allow emergency and municipal personnel time to bring emergency conditions under control."

There are no emergency orders at this time, officials say. This is not the first time St. Lawrence County has

New record temperature

Wednesday was the hottest day on record in Massena and Gouverneur, according to the National Weather Service. Temperatures peaked at 87 degrees around 3 p.m. on Oct. 4 in Massena. The average temperature this time of vear ranges between 41-63 degrees, NWS says. NWS says the record low for Oct. 5 in Massena took place in 1948, when temps dipped to around 22. In the southern part of the county, NWS data shows a high temperature Wednesday of 83 degrees. The lowest temperature on Oct. 5 in Gouverneur was also in 1948, at 21.

taken action on migrants potentially being housed in the county.

On two separate occasions, Massena was in the news when a local hotel owner attempted to coerce the state into housing migrants at the Quality Inn hotel in downtown Massena.

That property was nearly foreclosed on in August by the county due to taxes not being paid for years.

Gary Melius, owner of the hotel, owed over \$385,000 in back taxes from the previous three years.

According to County Attorney Steve Button, the lien holder on the property made a payment to the county for the taxes owed to "protect the asset," which is likely the first step in their own foreclosure on the property.

Massena then popped up in the new a few weeks later when New York City Mayor Eric Adams said his administration was weighing their options to house migrants upstate, including at the Massena International Airport. Adams says the city no longer has the option of handling the influx within its own borders.

"New York City has run out of room. We are going to use any space that's available to take the pressure of New York City residents," Adams said at a press conference.

Local, state and federal officials pushed back on the idea, saying it was not within the law for a city mayor to force other municipalities to house migrants, despite Massena being listed on a report by Homeland Security Secretary Alejandro Mayorkas that identified the airport as a viable option. Massena officials at the time said they had zero communication from the state regarding the possibility, saying it appeared the state had not done their due diligence in considering the airport.

No further action was taken by the state and to this date no migrants have been housed in St. Lawrence County.

WellNow may stop accepting Excellus BCBS

MASSENA - WellNow Urgent Care clinics may soon cease relations with Excellus BlueCross BlueShield (BCBS) at all locations, citing poor reimbursement rates that don't fairly compensate providers at the clinics.

That change could have a dire impact on the WellNow clinics in Massena and Ogdensburg, which opened just over a year ago, according to WellNow officials.

In a letter sent to patients last week, WellNow President Sam Meites said the company made the "difficult decision" to notify Excellus BCBS they would no longer accept the insurance provider's coverage beginning Jan. 1, 2024.

Meites wrote that it was due to unfair compensation for providers who work for WellNow.

"Unfortunately, the rates we receive from Excellus BCBS for the care provided to their members have been flat for the past decade. At the same time, over the past five years, Excellus BCBS has continued to drive average rate increases to their members of more than 8 percent every year, generating more than \$130 million in profits a year. It's a simple equation: charge you more, pay your WellNow providers the same or less, boost profits for the insurance company,"

Meites said the rate reimburse-

ment is not sustainable for Well-Now clinics, which could potentially force WellNow to close clinics in a number of communities in New York.

In a separate link provided by Meites, WellNow went on to detail Excellus BCBS's financial status, saying since 2017 Excellus has profited around \$130 million per

The page also states that Excellus' CEO salary has averaged more than \$3 million annually.

Since 2017, the state of New York has approved an average rate increase to Excellus' patients of more than 8% per year, according to WellNow officials.

Despite the profits and rate increases, WellNow rates with Excellus have remained flat, Well-Now officials say

"The 2,500 healthcare professionals at our 75 WellNow Urgent Care sites in the state of New York have worked tirelessly to provide high quality, convenient care to our patients in communities across the state," Meites said.

Meites went on further, saying the essential care provided by WellNow is needed for patients that are seen "seven days a week for up to 16 hours per day."

"We also provide 24/7 access to care through our telehealth services. We have worked hard to play an essential role as a provider of quality, dependable healthcare in your community," he wrote.

Meites said it is the hope of WellNow officials that the clinics will still be able to accept Excellus BCBS in the future, however it is a very real possibility that some clinics will be forced to close if a deal is not struck.

Meites suggested patients reach out to Excellus BCBS to voice their support for a rate change, saving it is crucial to continued services.

"Your voice does matter. Contacting Excellus BCBS can help. You can share your concerns on your social media channels and post directly to their leadership and tell them that you want Well-Now in your network," he wrote.

Meites said WellNow will still continue to provide services for patients with Excellus BCBS even if a deal is not struck, however patients will have to pay for services entirely out of pocket.

"If we are unable to reach an agreement with Excellus, as of January 1, 2024, you can still receive care at WellNow Urgent Care clinics. However, that care will not be covered by Excellus BCBS insurance. The cost of care will be our current rate of \$165, plus the possibility of additional fees, based on services needed," he wrote.

"Together, with your voice, we hope we can encourage Excellus BCBS back to work out an agreement that's fair and will allow us to continue to best serve their members and sustain all of our NY urgent care centers," he concluded.

Forum planned to talk about public safety in the city

North Country This Week

OGDENSBURG — Ogdensburg Police are asking the community to come together on Oct. 25 at the Dobisky Center to address a rash of public safety issues impacting the

Topics officers are hoping to discuss include the homeless problem facing the city, an increase in thefts from buildings, cars and property, increases in drug problems and mental health issues as well as other problems community members might want to bring forward.

"We are hoping to speak to the community in order to help come up with solutions for these problems," Lieutenant Jarret Leclair said in a media release.

The problems facing Ogdensburg aren't new, but the number of occurrences, at least anecdotally, appear to be rising.

In recent years the Ogdensburg City Police Department has seen dramatic cuts to staffing from 27 sworn officers to a one-time low of 16. Currently there are 18 positions and the upcoming budget would bring that to 19. However, that includes school resource officers as well as officers hired to provide security at the city airport.

At a Tuesday council meeting Ann Loffler raised major concerns about public safety in the city.

"I think what needs to be addressed right now is what's going on in the city. The thefts. It's ridiculous," she said.

Ogdensburg police said that thefts have been on the rise in the city, as have reports of homelessness and calls related to mental health issues.

Loffler said she came before council in 2021 warning that things were getting bad and would continue to get worse. She said she was accused of instilling fear.

She said the city needs to invest in public safety.

"We need more police. We need

more patrols," she said. "What do you guys plan to do?'

Leclair says that while staffing has certainly put additional stress on the city's police force, changes at the state level have made policing

He said bail reform and other state changes have created a revolving door for low level criminals.

He says police are frequently arresting the same person for the same crime over and over.

He said that he doesn't blame the judges or the district attorney's office, as he believes the state has tied their hands.

Loffler told councilors Monday that the city's decision to cut law enforcement has had severe conse-

The drugs, (overdoses) in this town. The thefts. The burglaries. We just had a murder of a young boy. During the day time we had an armed robbery... by a homeless person," she said. "You have to worry when you go to bed. It's ridiculous," she said.

Loffler asked the council what they thought would happen when they cut law enforcement.

"What in God's name did you guys think was going to happen? You laid out a doormat for every thief, drug dealer and drug addict to come into Ogdensburg and God bless you, you got it."

Leclair says he's hopeful community members will attend the Oct. 25 event. He says police are hoping to partner with community members interested in making a difference.

He said that he knows the public is frustrated and said the department is as well.

Leclair said that the department is doing the best it can with the resources it has, but that in many instances more severe crimes are pushing smaller crimes to the back

Leclair said one detective is currently handling the cases that were once handled by five detectives.

Leclair said he's hopeful that a conversation between law enforcement and the community can lead to some good ideas and he remains hopeful that state officials will make necessary changes to close the revolving door.

"I think they were trying to make things better, but it's clearly backfiring and the people that are suffering are members of the community," he

School adopting diversity, equity policies

MASSENA — The Massena Central School District has made progress in implementing a number of Diversity, Equity and Inclusion (DEI) policies in recent weeks.

According to Director of Curriculum Nicole Charleson, the district is working closely from the New York State Culturally Responsive Sustaining Education Framework, as was previously outlined in a meeting earlier this year.

"The CR-S framework helps educators create student-centered learning environments that: affirm racial, linguistic and cultural identities; prepare students for rigor and independent learning, develop students' abilities to connect across lines of difference; elevate historically marginalized voices; and empower students as agents of social change," according to the state program's website.

Charleson said she likes the language set forth in the framework, noting that the framework is grounded in a cultural view of learning and human development "in which multiple expressions of diversity, for example, race, social class, gender, language, sexual orientation, nationality, religion, ability, are recognized and regarded as assets for teaching and learning."

Charleson recently told board of education members that it was crucial to focus on creating a welcoming and affirming environment, which "really speaks to the work of Advisory, Sources of Strength, and the DEI work that we're beginning."

Following efforts to raise awareness among the community, Charleson said they will move onto phase two, which includes processes, policies, procedures and building capacity.

"We aren't exactly honing in on the policy part. We're more building the capacity part, the implementing part,"

Initial steps were taken in January when the district reviewed the Framework in January, followed by surveys completed during the spring.

Part of the work completed by the district included forming a district DEI committee, as well as analyzing survey data, Charleson said.

From there, building committees will be created for each school within the district to ensure full representation throughout the district.

We are currently in the fall of 2023, and now we are in implementation of the welcoming and affirming environments," Charleson said.

Massena man offers thoughts on tragic anniversary

Editor's Note: This letter contains references to sexual violence. A sad anniversary is upon us.

For anyone who is younger than Gen X, there is probably actually no reason for you to continue reading, unless perhaps for a little historical context, because fortunately, you already get it.

On October 6, 1998, Matthew Wayne Shepherd, then a 21 year-old University of Wyoming Student, was beaten, tortured, and left to die near Laramie, WY. He died at hospital six days later on October 12, 1998. Matthew was robbed, pistol whipped, and beaten so badly that his face was "completely covered in blood, except for where it had partially cleansed by his tears". Matthew was left tied to a fence, and remained so, in a coma, for 18 hours, until he was discovered by a passing cyclist. Two suspects in the case were eventually charged and convicted of his murder.

Testimony brought out at trial, and available in transcripts for any to read, indicated that the suspects specifically targeted Matthew "because he was gay" or "because they at least thought that he was gay".

I have read some suggestions indicating that for anyone going through confusion or lack of understanding about their sexuality, that their exclusive educators/enforcers are the parents, and that there is no place for churches, or any other resources...and that "therapy" instead is what may be required.

In Garrard Conley's 2016 Memoir, "Boy Erased", the author details his experience of being a 19 year- old college student, conflicted about his sexuality, when he was raped by his college dorm mate and then subsequently outed as gay to his parents, by this same person who raped him. The only son of a Baptist Minister, Mr. Conley was issued an ultimatum by his father to either enter the 'Love In Action -Ex-Gay" program, or be disowned by his parents, both literally and financially. Mr. Conley details his experience, as well as that of his other "classmates" in this un-vetted, unlicensed, program, where participants were literally beaten with

In an afterword, an update in the film version of Mr. Conley's Memoir, to the "Love In Action – Ex Gay" program is provided, in which we are informed that the male "Headmaster" of this now dissolved former Conversion Therapy program, is now happily living in Texas. With his husband.

Both Matthew Shepherd and Garrard Conley were from my generation

Mr. Conley is only a few years younger than myself, and I was in grad school while Matthew Shepherd had begun his undergrad studies

While commemorating the tragic, unnecessary, and disgusting anniversary of the brutal, hateful, murder of Matthew Shepherd, I would also like to take this opportunity to apologize to the generations younger than mine, for those in my generation, and older, whom cannot seem to stop themselves from telling you just how much that you have no right to be who you are.



community and in the path ahead. I moved here with my family five months ago, with the intention of



MASSENA — Businesses hoping to receive a chunk of the \$540,000 put aside in the village of Massena's Core of the Community Fund are encouraged to submit their applica-

Village officials say the deadline to apply is Oct. 17 for businesses within the Downtown Revitalization Initiative (DRI) target area.

The village of Massena was awarded \$10 million through the state's DRI program in 2021, intended to jump start work in the downtown corridor that would promote local businesses and provide new opportunities for economic growth.

As part of the initial application through the Local Planning Com-

mittee (LPC), the Core of the Community Fund was one of over two dozen projects in consideration.

When all was said and done, eight projects were selected by the LPC and state for funding through the

According to Village Administrator Monique Chatland, \$540,000 is available for local businesses looking to create new or update signage, to expand or renovate spaces, to improve facades and storefronts and to convert vacant property into usable commercial and residential spaces.

Fifty percent of project costs must be covered by property owners of for-profit businesses, while only 25% must be contributed for nonprofit businesses.

If projects run over projected

budgets, business owners will be on the hook for the difference and additional grant funding will not be supplied, officials say.

I will say that the property owners must fully fund the project and then will be reimbursed at the completion of the grant. There's different percentages based on what you're doing for the projects," Chatland said.

Project guidelines are available on the village's website at the following link: https://massena.us/537/ Core-of-the-Community-Grant-Fund.

The project funding is not just limited to property owners as well, business owners are eligible to apply as long as they are within the DRI boundary, Chatland said.

"It's actually pretty large," Chat-

To apply, businesses can do so on the village website as well, www. massena.us and completed applications can be submitted to jkonkoski2@labellapc.com.

"Those applications are due Oct. 17. We will review them the following week and a public review committee will have their decision the week after that," Chatland said.

If funds are not exhausted in the first round of approved projects, Chatland said it may be possible to set up a second round of applications in the future.

Numerous businesses are cur-

rently eligible within the zone, which runs from Andrews Street west to Church Street, south to West Orvis Street, west to Church Street. from East Orvis Street east to Parker Avenue, from Glenn Street south to East Orvis Street, from Phillips Street east to Water Street, from Main Street north to Maple Street,

from Water Street northwest to Main Street, from Center Street east to Parker Avenue bridge and from Maple Street east to Center Street.

Officials say it is their hope that after extensive behind the scenes work throughout the year that projects will be shovel ready next



The idea of raising allotments from Massena Electric has been broached multiple times in recent years as many customers complained about higher than expected bills during the winter months.

Lashomb was critical of power generated in the North Country being sent to the southern parts of the state, saying if it is produced here "we should benefit."

Officials say Massena Electric is on top of the situation, having studied the potential impact for years now. Town of Massena Attorney Eric Gustafson, who also serves as

Massena Electric's attorney, said it is a major concern for the board.

"The state is encouraging electrification of many things that were done with fossil fuels and how it's all going to shake out is something that they're actively pursuing," Gustafson said.

Local officials have also raised concerns about the transition to electric vehicles, with many reaching out to state and federal officials to address those concerns and delay implementation.

State officials passed regulations this year in the state budget bill that would require school districts to transition to all electric vehicles by 2027, however districts can apply for a two-year delay in implemen-

Comptroller Angela Gray said the proposed budget would exceed the state tax cap by 94 percent.




